2010 Phelps County Fair Pageant

GUIDELINES

1. Enter appropriate division, according to their age at time of pageant.
2. Judging will be based on - Stage Appearance, **where applicable** - Public Speaking, Interview, Talent (if applicable). Talent may include poem reading, skit, speech, musical instrument, singing, dance, etc. All candidates must also understand that by their participation, they agree that any and all pictures will be used to promote the Phelps County Fair.
3. Orientation for Little Fair, Jr. Fair, Fair Princess, and Fair Queen will be at 5:30 PM at the Grove on **June 21, 2010**. This starts your first practice and you may turn form in or sign up that night. Contestants **must attend 7 out of 9 practices and the last two practices are MANDATORY**.
4. Forms must be submitted by **June 21, 2010** for Queen, Princess, Jr. Princess, and Little Princess. For all other divisions forms due and orientation is **July 10, 2010** at 9:30 AM at the Grove.
5. Each pageant competition will immediately follow each other beginning with Queen or Baby division. Contestants agree to abide by all rules of the PCF Pageant that are in affect now or as announced later. Contestants agree the time, manner, and method of judging shall be solely at the discretion of the PCF and that the **decision of the judges will be final.**
 - a. Contestants shall be citizens of the U.S.
 - b. Contestants shall have residents of the County of Phelps in the State of Missouri six months prior to the Pageant.
 - c. Contestants shall be single.
6. Entries shall be postmarked no later than **June 21, 2010** for ages 7 -21 and **July 10** for ages 0 -6. Mail to: Phelps County Fair Pageant, Tina Goolsby, PO Box 833, Rolla, MO 65402.
7. Official form filled out completely, signed acknowledging guidelines are understood and will abide.
8. The PCF winner will automatically relinquish her title if she enters into a marriage contract, if she chooses to cohabit with a male in lieu of marriage, becomes pregnant, or currently has children.
9. Conduct deemed to be improper and/or detrimental to the Directors, Board, or the PCF Pageants, will be reason for disqualification and dismissal by the Directors and/or Board.
10. Contestants may not have tattoos or body piercing exposed during practices or competition. Smoking is prohibited at all times. Should you be selected as winner - this guideline also applies.
11. If Pageant winner fails to complete his or her term, the title will be passed to the runners-up in the order of their rank, beginning with 1st runner-up, if time is allotted for new title holder.
12. **Any contestant, family members, or friend(s) of contestant observed bashing other contestants, the contestant will be immediately disqualified without warning. This is strictly enforced.**
13. Dress code will be announced at first practice.
14. I understand that my duties will be designated by the Fair Queen, the Board, or the Pageant Directors. Winner agrees to work at the 2010 Phelps County Fair during the duration of the fair beginning at 8 AM – 11 PM.
15. **NO CONTESTANT MAY ENTER ANY DIVISION IF HOLDING A CURRENT TITLE OF ANY KIND SUCH AS CURRENT PCF, HOLIDAY, SWEETHEART, MISSOURI OUTDOORS, SHOW ME STATE, ROUTE 66 OR SURROUNDING COMMUNITIES. This also includes Preliminary, State, Internet, Magazine, and alike. If you are in question if you qualify or not, please contact Tina Goolsby at 573.308.7531.**
16. I understand that my duties will include presenting ribbons, trophies, and other duties including activity that will be held at the fairgrounds during the year (Demo Derby, Mud Run, Livestock, Fundraisers, clean-up, and etc.) as designated by either the Fair Board or the Pageant Directors. You are also required to assist with the PCF Holiday Pageant.
